### **GENERAL INFORMATION**

**Integrate 20** improves initial wetting and subsequent rewetting of agricultural soils. It is formulated to ensure maximum uptake of water on coarsely textured hydrophobic soils. It will provide uniform penetration and lateral movement of water which in turn encourages improved rooting and nutrient uptake leading to greater plant health.

**Integrate 20** is labeled for use on all agricultural crops including strawberries, Cucurbits, tomatoes, corn, peppers, melons, onions, potatoes, etc.

**Integrate 20** can also be applied to turf including golf course greens, tees and fairways, athletic fields as well as production sod.

### Measurement (net contents): In US Gallons packaged in 2.5 and 30.

### DIRECTIONS FOR USE

**Agricultural Crops:** Initial application: **2 Quart** per acre either injected in 100-200 gallons of water or blended in the first load of Liquid Fertilizer for that respective block of acres of production dedicated to that pump station.

Subsequent applications at **1-2 Quarts** per month per gross acre either injected or blended with Liquid Fertilizer regardless of the volume of fertilizer being fed. For example: If you feed every other day in a given month, divide 1-2 Quarts per acre in the block/pivot/field and divide that by 15 days of fertilization giving you the amount of Integrate per fertilization cycle.

**Drench: Integrate 20** can be added to drenching water by using .5%-1% solution.

**Turf:** Initial application of 2 Quarts per acre followed by 1-2 Quarts per acre monthly or as needed.

Additional applications may be needed for extremely dry conditions in hydrophobic soils.

**Application Methods:** Drip, Center Pivot, Overhead Irrigation, Boom Sprayer or drench. **Integrate 20** may be blended with Liquid Fertilizer and injected via irrigation system and is compatible with most LF. Standard compatibility jar test is recommended.
